# USPTO fee schedule

Effective January 19, 2025 (Last revised July 1, 2025)

The fee schedule provides information and fee rates for USPTO's products and services. All payments must be paid in U.S. dollars for the full amount of the fee required. View the [Accepted payment methods](#) page or call the USPTO Contact Center at 571-272-1000 or 800-786-9199 for assistance.

## Fee schedule changes effective July 1, 2025:

### PCT fees to foreign offices:

- 1701: International filing fee (first 30 pages - filed electronically without ePCT or PCT-EASY .zip file) – fee increase from \$1,347 to \$1,482
- 1710: International filing fee (first 30 pages - filed electronically with ePCT or PCT-EASY .zip file) – fee increase from \$1,237 to \$1,362
- 1702: International filing fee (first 30 pages) – fee increase from \$1,456 to \$1,603
- 1703: Supplemental fee (for each page over 30) – fee increase from \$16 to \$18
- 1704: International search, European Patent Office (EPO) as International Searching Authority (ISA) – fee increase from \$1,905 to \$2,094
- 1716: International search, Japan Patent Office (JPO) as ISA – fee increase from \$1,075 to \$1,179
- 1705: Handling fee – fee increase from \$219 to \$241
- 1706: Handling fee - 90% reduction, if applicant meets criteria specified on the [WIPO table](#) – fee increase from \$21.90 to \$24.10

Except for provisional applications, each application for a patent requires the appropriate search fee and examination fee in addition to the appropriate fees in the "Patent application filing fees" section below. This means each fee listed as a "Basic filing fee" in the "Patent application filing fees" section should be accompanied by the appropriate search fee listed in the "Patent search fees" section as well as the appropriate examination fee listed in the "Patent examination fees" section. The \$400/\$200 non-electronic filing fee (fee codes 1090/2090/3090 or 1690/2690/3690) must be paid in addition to the filing, search and examination fees, in each original nonprovisional utility application filed in paper with the USPTO. The only way to avoid payment of the non-electronic filing fee is by filing your nonprovisional utility application via Patent Center. The non-electronic filing fee does not apply to reissue, design, plant, or provisional applications.
